- Is in the service of the state
- If that person is not a natural person, of which any director, manager, principal shareholder or stakeholder is a person in the service of state
- Who is an advisor or consultant contracted with the municipality or municipal entity.

A Preferential Point system shall apply whereby a contract will be allocated to a bidder in accordance with the Preferential Procurement Policy Framework Act, Act No 5 of 2000 and as defined in the Conditions of Tender in the tender document, read in conjunction with the Supply Chain Management Policy of Thembisile Hani Local Municipality where 90/80 points will be allocated in respect of price and 10/20 points in respect of B-BBEE Status Level of Contribution, respectively.
